**NOTICE OF PUBLIC AVAILABILITY OF TEXT MODIFICATIONS AND  
AVAILABILITY OF DOCUMENTS ADDED TO THE RULEMAKING FILE**

AMENDMENT TO TITLE 5, CALIFORNIA CODE OF REGULATIONS REGARDING,  
CAL GRANT PROGRAM APPEAL PROCESS  
(EDUCATION CODE SECTION 69432.7)

Pursuant to the requirements of Government Code section 11346.8(c) and section 44 of Title 1 of the California Code of Regulations, the California Student Aid Commission is providing notice of text modifications made to proposed regulations regarding the Cal Grant Program Appeal Process. The Notice of Proposed Rulemaking for the originally proposed amendments was published in the Office of Administrative Law's California Notice Register on November 27, 2020 (See Register 2020, No. Z2020-1117-08.) The 45-day comment period for the amendments began on November 27, 2020 and ended on January 13, 2021.

Commission staff is now proposing text modifications to the proposed regulations as set forth below. The revisions are substantially related to the originally proposed text, and are being made available for public review and comment for a period of at least 15 days prior to adoption. All revisions are shown with double underline for new language and ~~double-strikeout~~ for deleted language.

**WRITTEN COMMENT PERIOD**

The Commission will accept written comments regarding those proposed changes and the Amended Initial Statement of Reasons for at least 15 days beginning on July 29, 2021 and closing at 5:00 P.M. on August 13, 2021. Please address your comments to:

Comments on the revised text of the proposed regulations should be limited to the current modifications denoted by double underline for new language and ~~double-strikeout~~ for deleted language.

Commission staff has revised section 30049 to provide increased clarity concerning how and when the Commission will notify institutions of their appeal status following the submission of a complete appeal package.
