Starting with the 2022-23 academic year, the University of California (UC) will be implementing a cohort-based tuition model that assess varying system wide fees dependent on the academic year the student entered the UC system as approved by the UC Board of Regents in July 2021. California Education Code requires the California Student Aid Commission (CSAC) to offer the Cal Grant (CG) Tuition/Fees award (T/F) equal to the assessed system wide T/F at any public University. The Cal Grant A and B tuition award for UC mandatory systemwide tuition and fees are at \$12,570 for UC “Cohort 0” students and \$13,104 for UC “Cohort 1” 2022.
