





2007-2008 Financial Need Analysis Availability

This Operations Memo is to provide you with an update on the California Chafee Foster Youth Grant Program (Chafee Program) and the 2007-2008 Financial Needs Analysis Report (NAR) availability.

### 2007-2008 Financial Needs Analysis (NAR) Availability

The 2007-2008 NAR is now available on the California Student Aid Commission's (Commission) *WebGrants*. As stated in GOM 2007-08 the Chafee Program 2007-2008 NAR is now available for processing for new and renewal applicants. Commission staff is currently processing the paper NARs for the 2007-2008 academic year and will continue to due so. However, the recommended method for NAR submission is on *WebGrants*.

### 2007-2008 Chafee WebGrants Download Reports

The 2007-2008 *Chafee Need Analysis Roster* and 2007-2008 *Chafee Status Roster by Schools* are now available on *WebGrants*. Schools may access the 2006-2007 and 2007-2008 *Chafee Need Analysis Roster and Chafee Status Roster* concurrently. The reports will be updated weekly with each award cycle. The Commission recommends that schools regularly check the reports for both academic years.
