## **Coordinator' Guide** Assumption Program of Loans For Education (APLE) **Credentialed Teachers**

### **2011-12 Academic Year**

The California Student Aid Commission (Commission) is pleased to announce the start of the application processing cycle for the **APLE for Credentialed Teachers for the 2011-12 academic year.**

#### **What is APLE for Credentialed Teachers?**

The APLE for Credentialed Teachers is designed to encourage credentialed teachers to seek and teach in K-12 teaching positions in California's public schools. Credentialed teachers must be employed and agree to continue to teach in a K-12 California public school that is ranked in the lowest 20 percent on the Academic Performance Index (API).

Selected participants will be eligible for the loan assumption of up to \$19,000\* of their outstanding educational loans in return for four (4) consecutive years of full-time teaching service or consecutive part-time teaching for the equivalent of four (4) full-time academic years in a California public school ranked in the lowest 20 percent on the API.

*\*APLE Credentialed Teacher participants who agree to, and provide, four (4) years of consecutive teaching service, or the equivalent on a part-time basis, in math, science, or special education may receive up to \$2,000 of additional loan assumption benefits each year for a total of \$19,000 when they continue to teach in an eligible school ranked in the lowest 20th percentile of the Academic Performance Index.*

#### **County Office of Education Role**

California County Offices of Education are responsible for accepting and submitting completed Credentialed Teacher applications and Loan Assumption Agreements to the Commission.

Additionally, the County Offices of Education will certify the type of credential the credentialed teacher holds and the number of years the applicant has taught at a school ranked in the lowest 2 deciles on the API.

The APLE for Credentialed Teachers allocation of 400 will be awarded by the Commission. The awards will be distributed among the participating California County Offices of Education.

The participating County Office of Education must sign an Institutional Participation Agreement (IPA) **prior** to the Commission being able to accept any nominated applications. ## Eligible APLE Credentialed Teacher applicants must:

- ▶ Currently be teaching in a public school ranked in the lowest 20 percent on the API;
- ▶ Possess a clear multiple subject or single subject teaching credential or Level II education specialist credential;
- ▶ Submit an APLE Credential Application to their County Office of Education;
- ▶ Submit a completed Loan Assumption Agreement to their County Office of Education;
- ▶ Agree to continue to provide four full-time consecutive school years, or the equivalent on a part-time basis, of qualifying teaching service at a public K-12 school that is ranked in the lowest 20 percent;
- ▶ Have received one or more of the following educational loans: Stafford Student Loan (Subsidized/ Unsubsidized), Federal Direct Student Loan (Subsidized/Unsubsidized), National Direct Student Loan, Supplemental Loans for Students, or Consolidation Loan Program Loans issued to students through institutions of higher education for the purpose of defraying costs associated with obtaining a postsecondary degree or an initial teaching credential;
- ▶ Have no repayment obligation for any state or federal educational grant(s);
- ▶ Have not defaulted on any student loan; **and**
- ▶ Not have participated in and received benefits from the APLE Program.

## Submission of Applications

Coordinators shall provide an APLE Credentialed Teachers Application and Loan Assumption Agreement to **all interested teachers**.

Each County Office of Education shall allow all interested credentialed teachers to submit applications if they meet the APLE eligibility criteria.

Once all forms have been reviewed for accuracy completeness and certified the County Coordinator must list each applicant's name and Social Security Number on the Submitted Applications Summary Sheet.

The APLE for Credentialed Teachers Coordinator shall submit the following documents to the Commission:

- ▶ Application Selection and Statistics Summary
- ▶ Submitted Applications Summary Sheet
- ▶ Applications **and** LAA's for each listed applicant

All documents must be submitted and received at the Commission by the **priority deadline of September 30<sup>th</sup>** to be considered in the initial allocation process. Coordinators may continue to accept and submit applications to the Commission in an effort to meet state mandated allocations.

## Commission's Role

The Commission will accept applications from all participating California County Offices of Education.

The awarding of the 400 allocations will be **competitive** and will follow California Code of Regulations Section 30705(d). The Commission will notify applicants of their selection into the program.

Additionally, the Commission will provide program participants with information to ensure the optimum receipt of benefits from the program.

I, the undersigned APLE participant, understand and agree to the following:

**SECTION I - TEACHING REQUIREMENTS**

**I must:**

1. Credentialed teacher must possess and maintain a clear multiple subject or single subject teaching credential or level II education specialist credential in California.
2. Maintain full-time, or part-time equivalent, eligible teaching service in a California public school that is ranked in the lowest 2 deciles on the Academic Performance Index (API).
3. Not be a previous participant in the Assumption Program of Loans For Education.
4. Provide eligible teaching service for four full-time, or the part-time equivalent for four (4) consecutive school years at an eligible school that is ranked in the lowest 20% of the Academic Performance Index.

**SECTION II - EDUCATIONAL LOAN OBLIGATION**

**I must:**

1. Report **all** outstanding educational loans to the California Student Aid Commission (Commission) prior to receiving payment.
2. Comply with all student loan repayment obligations and continue making scheduled payments on student loan(s) until notified by my lender that the loan is paid in full. I understand that an APLE loan assumption payment will not cancel or replace any scheduled student loan payments.
3. Provide written notification to the Commission within 10 days of any change in the status of my student loans, including notice of default and the sale, transfer or consolidation of my student loans to another lender or servicer.
4. Be free of any obligation to repay any state or federal educational grant and not be in default on any student loan.

**SECTION III – LOAN ASSUMPTION BENEFITS**

**I understand that in order to qualify & receive the full APLE for Credentialed Teachers benefits I must:**

1. Provide eligible full-time, or its equivalent on a part-time basis, teaching service in a California public school for four (4) consecutive, or its equivalent school years in a California public school ranked in the lowest 2 deciles of the A.P.I. (Previous credential teaching service does not apply.)
2. Acknowledge the term of the loan assumption agreement shall be no more than 10 years from the date signed by me and accepted by the Commission.
3. Acknowledge loans eligible for loan assumption payments are educational loans under the Federal Family Education Loan Program (20 U.S.C. Section 1071, et seq.) and any educational loan approved by the Commission.

**SECTION III - LOAN ASSUMPTION BENEFITS (CONT.)**

4. The Employment and Loan Verification Form(s) must be forwarded to the appropriate officials for completion and submitted to the Commission. The forms must be returned by the deadline to qualify for benefits. If I fail to meet a deadline, I will be withdrawn from the program.
5. Educational loans obtained for coursework other than a baccalaureate degree and an initial teaching credential **are not** eligible for assumption under the APLE for Credentialed Teachers.
6. Depending on my June 30<sup>th</sup> outstanding loan balance each year and the state budget\*, the Commission may issue loan assumption payments directly to lender(s)/servicer(s) as follows:
  - Up to \$2,000\*\* after completing my first school year of eligible full-time, or on a part-time basis for the equivalent, teaching service.
  - Up to \$3,000\*\* after completing my second consecutive school year of eligible full-time, or on a part-time basis for the equivalent, teaching service.
  - Up to \$3,000\*\* after completing my third consecutive school year of eligible full-time, or on a part-time basis for the equivalent, teaching service.
  - Up to \$3,000\*\* after completing my fourth consecutive school year of eligible full-time, or on a part-time basis for the equivalent, teaching service.
7. Loans which are eligible for total or partial cancellation under state or federal provisions will never be eligible for assumption under the APLE for Credentialed Teachers even if I do not apply for the cancellation benefits or do not qualify for the benefits during subsequent years of eligible teaching service.
8. If the Commission determines that any loan assumption payment was authorized based on misleading or incorrect information, I must reimburse such payment to the Commission.

**SECTION IV - ADDITIONAL REQUIREMENTS**

**I must:**

1. Respond to all communications and requests from the Commission within the time indicated or I may be withdrawn from APLE for Credentialed Teachers .
2. A pre-approved leave of absence (LOA) may be authorized by the Commission should you encounter difficulties with program requirements. Qualified LOA's are outlined in CEC 69613.6.
3. Comply with any procedures deemed necessary and appropriate by the Commission, all conditions cited in this Agreement and all applicable rules and regulations. **If I fail to comply, this Agreement will become invalid and I will be withdrawn as a participant.**

\*\*\$1,000 of additional loan assumption benefits per year may be provided if I teach mathematics, science (grades 7-12), or special education in a school ranked in the lowest 60th percentile of the A.P.I. If I teach in these subject areas in a school ranked in the lowest 20th percentile of the A.P.I. I may be eligible for an additional \$1,000 after each year of service, up to four years.


## **State of California Information Practices Act (IPA) of 1977 & Use of Your Social Security Number**

The **APLE for Credentialed Teachers** is a competitive teacher incentive program designed to encourage credentialed teachers to apply for, accept teaching positions, and continue teaching in California K-12 public schools that are ranked in the lowest 20 percent on the Academic Performance Index (API).

Applying for the APLE Credentialed Teachers is a two-step process. The applicants need to:

- 1) Complete and sign the application and Loan Assumption Agreement (LAA); **AND**
- 2) Submit both documents to your County Office of Education APLE Credentialed Teacher Coordinator for submission to the California Student Aid Commission (Commission).

## Tips for Credentialed Teacher Applicants

### Applicants must:

-  Be currently teaching at an eligible public K-12 school ranked in the *bottom 20% of the API*; (defined by the CA Department of Education as a *Rank 1 or Rank 2 school*)
-  Have received one or more educational loans that still have an outstanding balance;
-  Have not previously participated in and received benefits from the APLE;
-  Not be in default in any state or federally insured educational loan;
-  Submit a completed Credential Teacher Application to your County Office of Education;
-  Submit a signed Loan Assumption Agreement with your application to your County Office of Education;
-  Submit application and Loan Assumption Agreement to your County Office of Education APLE Coordinator.

## Timeline of Application Process

- **May** – Applications, Loan Assumption Agreement's, and Coordinator's Guide received by the participating County Office(s) of Education
- **June - September** – County Office(s) of Education submit applications and Loan Assumption Agreements to the Commission by priority deadline of September 30<sup>th</sup>.
- **November** – Program participants are announced by the Commission
