

Ineligible Cal Grant Schools for 2013-14

Cal Grant participating colleges, universities, and career technical schools must meet various eligibility requirements in law to be able to receive Cal Grants. The two required thresholds* for the 2013-14 academic year are:

1. Schools must keep their federal student loan Cohort Default Rate (CDR) below 15.5 percent.
2. Schools must keep their graduation rate above 30 percent.

Institutions with a three-year CDR below 10 percent and a graduation rate above 20 percent may remain eligible through the 2016-17 academic year due to a limited exception in law.
