The application is used to determine the eligibility of AB 540 students for California student financial aid for the 2014-15 school year. The California Student Aid Commission will process this application. The state Cal Grant deadline is March 2, 2014\* Any aid offered can only be used at eligible California institutions.

If your parent is not available to sign the Dream Act Application online, then complete this form and submit it to the address below. This signature page is to be used with the Dream Act Application only and cannot be used to sign the Free Application for Federal Student Aid (FAFSA), The FAFSA application can be signed on-line at [www.fafsa.gov](http://www.fafsa.gov). Do not submit this form prior to completing the Dream Act Application.

### Follow the instructions below to submit a complete signature page

#### Step One: Confirm that your current Dream Act Application information is correct

You can verify the information on your Dream Act Application and sign the application by going to <https://dream.csac.ca.gov/> and hitting the "Retrieve my Information" button.

#### Step Two: Read the following:

**Students: By signing the Dream Act signature page and mailing it to us, you certify that:**

1. The information you provided on the Dream Act Application is accurate and correct,
2. You will use the state student financial aid only to pay the cost of attending a qualifying institution of higher education in California,
3. You are not in default on a federal student loan or have made satisfactory arrangements to repay it,
4. You do not owe money back on a federal or state student grant or have made satisfactory arrangements to repay it and,
5. You will notify your college if you default on a federal student loan.

**Students and Parents: By signing a signature page and mailing it to us, you agree, if asked:**

1. To provide information that will verify the accuracy of your completed form.
2. To provide proof of filing to your college if you or your parent filed federal income tax forms.

The signatures below certify that you understand that the State of California and your college have the authority to verify information reported on your application with Federal and State agencies. If you purposely give false or misleading information, you may face criminal penalties.

#### **Applying by the Deadlines**

Submit the Dream Act Application as early as possible. The state Cal Grant deadline is March 2, 2014\* but we will process your application for other college programs as late as June 30, 2015. We will send the application to the colleges you list on the application. Your college may require additional forms and need your correct, complete information by any deadline that they may have. Check with your college to determine their application deadlines and filing requirements. In addition to a completed Dream Act Application with signatures, the state Cal Grant program requires a school certified GPA. Check with your high school counselor or a college financial aid administrator to see if they will be submitting your GPA. If they are not submitting your GPA for you, go to <http://www.csac.ca.gov/doc.asp?id=1177> to download the GPA form.
