Instructions for Completing the Summer Payment Request Form for Students

Newly awarded 2009/10 Cal Grant A and B recipients may not activate their grant for the summer 2009 school term. New recipients begin payment with the fall 2009 school term. Payment for non-mandatory summer coursework (June-August 2009) is available for students renewing an award from the 2008/09 school year. In order to receive summer payment, the Commission must receive your request, no later than the end of your summer term.

Cal Grant C payments for Summer 2009 are available for course work which begins on or after July 1, 2009. Your school should request payment by August 31, 2009. You must be enrolled at least half-time to be eligible for summer payment.

You may request payment for the Summer 2009 school term after March 1, 2009.

Please note: Summer payments will reduce your total program eligibility for Cal Grant benefits. Be sure to consult with your school financial aid office to maximize the use of your Cal Grant.

Section 1 — Student Information (This section must be completed)

1. Enter your name (last, first, middle initial). Remember to print or type clearly.
2. Permanent address - street address, city, state and five- or nine-digit zip code.
3. Summer address - if your address in the summer differs from your permanent mailing address.
4. Social security number or the CSAC ID number - enter as listed on your award or renewal letter.
5. Telephone number - enter a telephone number where you can be reached during the day, including area code.
6. Email address - enter an email address where you can be contacted, if necessary.

Section 2 — Summer School Enrollment Information

7. Enter the name of the school you currently attend.
8. Enter the name of the school you will be attending for summer, and the location of the campus.
(For example: College of Marin - Indian Valley Campus)
9. Indicate the start and end date of the summer term (For example: June 1 - August 10, 2009)
10. List the school you will attend for fall 2009
11. Your signature certifies to the best of your knowledge that this information is true and correct.
(To avoid delays, sign, date and mail or fax this form as soon as possible.)
