This form must be completed pursuant to the California Domestic Partner Rights and Responsibilities Act of 2003 (Act), enacted on September 22, 2003. The Act provides that registered domestic partners have the same rights, benefits and obligations as are granted to or imposed upon spouses in California, effective January 1, 2005. For purposes of financial aid, the State must consider the income and assets of a registered domestic partner of a student or a student's parent in the same manner as it would consider the income and assets of a spouse of a student or student's parent. Federal financial aid is not affected by these provisions.

1. Complete this form only if you or your parents have filed a Declaration of Domestic Partnership and received a Certificate of Registration of Domestic Partnership from the California Secretary of State and are applying for or receiving Cal Grant financial aid.
