**SUBJECT: California National Guard Education Assistance Award Program
15-Day Proposed Regulations Public Comment Period**

The purpose of this Special Alert is to announce the 15-day public comment period to review and respond to the proposed regulations for the California National Guard Education Assistance Award Program (CNG EAAP).

Government Code Section 11346.8(c) and Section 44 of Title 1 of the California Code of Regulations provide that changes in proposed regulations which are sufficiently related to the initially advertised text must be made available to the public for review and comment 15 days prior to the adoption of the regulations.

In response to comments received during the 45-day comment period, staff have reviewed and revised the original proposed text. All revisions and additions to the originally proposed (45-day notice) text are identified by ~~double-strikeout~~ of the text to be deleted and double underlining of the text to be added. All revisions and additions to the attachments of the originally proposed (45-day notice) text are identified by ~~double-strikeout~~ of text to be deleted and double underline of text to be added.

Comments addressing modifications in the text and attachments that appear in double strikeout and double underlining format will be considered.

The Public Comment Period for the modification of Proposed Regulations begins on March 8, 2010 and ends at 5:00 p.m. on March 23, 2010. Faxed, mailed, or emailed comments on the proposed modifications must be received by the California Student Aid Commission (Commission) no later than 5:00 p.m. on March 23, 2010 at the address on the following page.
