





**SUBJECT:** Webinar on the SB 70 Regulatory Process

---

On April 27, 2012, the California Student Aid Commission (Commission) authorized staff to commence the regulatory process, including drafting proposed regulations and accompanying documents, and to take the necessary steps to complete the regulatory process for Senate Bill 70 (SB 70) reporting requirements.

As part of the Commission's effort to consult with and acquire feedback from institutions, staff will host an on-line webinar to present more information on the reporting requirements proposal. In addition to the webinar, segmental representatives from the various institutions will have an opportunity to arrange a conference call to ask questions related to each segment.

Each webinar session will last one (1) hour. Participants can log on from their office or home computer and follow along screen-by-screen while listening to live audio feed over the telephone. Participants can submit questions through the "Chat" feature during and shortly after the conclusion of the presentation. All questions must be submitted in writing and will be collected and reviewed with responses provided at a later date.

The Commission will hold two webinar sessions on the following day and times:

May 3, 2012 from 10:00 a.m. to 11:30 a.m. **and** from 1:30 p.m. to 2:30 p.m.
