# **Ineligible Cal Grant Schools for 2023-24**

## (21 Total Ineligible Schools)

Cal Grant participating colleges, universities, and career technical schools must meet various eligibility requirements in law to be able to receive Cal Grants. The two required thresholds\* for the 2023-24 academic year are:

### 1. Schools must keep their federal student loan Cohort Default Rate (CDR) below 15.5 percent.

### 2. Schools must keep their graduation rate above 30 percent.
