SUBJECT: 2017-18 September 2 Competitive Cal Grant Reminder

This Operations Memo from the California Student Aid Commission (Commission) provides guidance to California Community Colleges (CCC) regarding the 2017-18 September 2 enrollment submission and Grade Point Average (GPA) processes for the Competitive Cal Grant A and B programs. These awards are for students attending an eligible CCC during the 2017-18 fall term.

Students who will be considered in the 2017-18 Cal grant CCC Competition are those who:

- Did not receive a March 2nd Cal Grant award
- Applied after the March 2nd deadline
- Completed a 2017-18 Free Application for Federal Student Aid (FAFSA)
 postmarked or posted online by September 5*, 2017
- Submitted a verified GPA to the Commission for the 2017-18 award year by September 5*, 2017
- Are listed on a 2017-18 CCC enrollment file

CCC Enrollment Verification and Submission

- Upload enrollment data files directly to the Commission through WebGrants.
 Users have the option to upload a complete data file or to enter individual records. The Enrollment Record Layout Specifications are the same as last year.
- CCCs should report all students enrolled for fall 2017, regardless of the number of units in which the student is enrolled.
- Both semester and quarter community college campuses must submit enrollment data no later than September 15, 2017.
- The Commission anticipates processing the September 2 Competitive Award cycle after all enrollment files are submitted.

Cal Grant GPA Verification and Submission

- Refer to the <u>Cal Grant GPA Calculation Instructions</u> for complete details on how to calculate a high school, college, community college or re-established GPA.
- Authorized school officials are encouraged to submit verified GPAs by uploading data files through WebGrants using the regular GPA upload option. Refer to the WebGrants GPA Upload Record Layout for the file specifications. The deadline for GPA submission is September 5*, 2017.
- If a student chooses to submit the paper <u>Cal Grant GPA Verification form</u>, advise the student to keep a copy for their records and obtain a U.S. Postal Certificate of Mailing, which must be postmarked no later than September 5*, 2017.
- Identify CCC re-established GPAs by choosing the re-established check box before uploading. When uploading both regular and re-established GPAs, each requires a separate data file upload.
- If completing a paper GPA Verification Form, fill in the oval that identifies the verified GPA as a re-established GPA, if applicable.
 - * Due to September 2, 2017, falling on a Saturday, followed by the September 4 Labor Day holiday; FAFSA applications submitted through September 5, 2017, will be considered as on-time. Likewise, 2017-18 Cal Grant GPA paper verification forms will be accepted if postmarked no later than September 5, 2017.
