#### **Definitions of Affordability**

The alignment between the student's desired educational goal and total cost, funding mechanisms, time to completion, and long-term improvement in that individual's quality of life attributable to their postsecondary education.

#### Afford-

- To manage to bear without serious detriment
- To be able to bear the cost of

#### Affordability-

- The extent to which something is affordable, as measured by its cost
- relative to the amount that the purchaser is able to pay.

#### And the answer is...??

- As the previous definitions demonstrate, there is not a universal definition that everyone agrees upon
- It depends in part on your perspective
- It is also relative to your situation, especially financially
- It depends on your reference point(s)

#### CSU Financial Aid (Big Picture) 2018-19 Numbers

- 388,519 CSU Students received aid (82% of all students)
- More than \$4.5 Billion in Total Aid
- 59% of <u>All</u> undergraduates have full cost of tuition covered by grants, scholarships or waivers
- 54% of CSU Bachelor's recipients graduate with zero student debt
- The average loan debt for CSU students was \$18,173 in 2018, compared with the CA average of \$21,485 and national average of \$29,200

#### Types of Gift Aid (Federal-FAFSA)

Gift Aid is money that the student does not have to pay back (i.e. grants and scholarships). Free money!

- Federal Pell Grant
- Federal Supplemental Educational Opportunity Grant (FSEOG)
- Iraq & Afghanistan Service Grant

## Types of Gift Aid (State-FAFSA or DREAM)

- •Cal Grants (A & B)
- Chafee Grant
- Middle Class Scholarship (MCS)
- CSU State University Grant (SUG)
- <u>CSU</u> Educational Opportunity Program (EOP)

#### Types of Self-Help Aid (Federal-FAFSA)

Sellf-Help Aid is money that students work for (work study) or money that must be repaid (loans)

- Federal Work-Study (FWS)
- Federal Direct Loans
- Federal PLUS (parent) Loan

#### How financial aid really works

- Each award program has its own terms/conditions
- Some awards must be adjusted based on enrollment (Pell, Cal grant)
- Many have limited funds (SUG, SEOG, FWS)
- Financial aid is highly regulated-Federal, state and institution-constraints

#### **Aid Application Cycle**

- Apply for Admission: 10/1-12/4 (normally 11/30) Priority Period
- Apply for Aid: 10/1-3/2 Priority Period, FAFSA or CADAA available through end of school year
  - Cal Grant GPA verification has a deadline of October 1
  - Receive admissions notification
- Receive award letter

#### OR

- Request for additional information (i.e. Verification documents)
  - Once documents are received and processed, the school will issue an award letter
  - Late submissions will delay awarding
- National Intent to Enroll deadline: May 1

#### Things to avoid (pitfalls)

- Applying late: California & CSU use a Priority Filing date for the FAFSA and DREAM applications of March 2
- Cal Grant uses March 2 as a firm deadline
- Some aid programs have limited funding
- May reduce the number and types of aid programs for which student will be considered

#### Student role/responsibilities

- Respond to requests for information from school
- Students may be selected for "verification," which requires they submit documents like tax transcripts
- Students should check their email often and their school online portals
- Respond promptly to requests
- Late responses may affect timeliness of award letters
