

# This document presents aggregate demographic information on the 2014-15 Competitive Cal Grants award new paid recipients. Total competitive new paid recipients: 21,815.

### CAL GRANT A&B

#### **Competitive Program**

Competitive Cal Grant A awards paid tuition and mandatory systemwide fees of up to \$12,192. Competitive Cal Grant B awards paid \$1,648 in living expenses in the first year, and \$1,648 in living expenses plus tuition and mandatory systemwide fees of up to \$12,192 beginning in the second year of eligibility.

Under Senate Bill 1644 (Chapter 403, Statutes of 2000), California students who do not receive an Entitlement Cal Grant A or B award may compete for a Competitive Cal Grant A or B award. These awards are not entitlements. The statute set the number of awards available at 22,500.

Fifty percent of the Competitive Cal Grant A and B awards are available to all students who meet the eligibility criteria and apply by the March 2nd Cal Grant application deadline. The remaining fifty percent are reserved for students who will be enrolled at a California Community College (CCC). CCC students are eligible to apply by either the March 2nd or the September 2nd Cal Grant application deadline.


The data in this document reflect the 2014-15 Competitive Cal Grants awarded

to qualified applicants who applied by one or both deadlines, received award offers, attended Cal Grant participating institutions, and were subsequently paid. It also includes recipients who were awarded in previous years but were first paid in 2014-15.

For 2014-15, 25,660 students were offered Competitive Cal Grant A and B awards, of which 20,884 actually used their awards and became Paid Recipients, and an additional 931 new paid recipients awarded in previous award years. These include 382 Cal Grant A and 21,433 Cal Grant B awards.


Some items of note include:


- In 2014-15, 21,433 of 21,815 (98%) students were Cal Grant B recipients (Table 1, p. 1).
- Around 58 percent of recipients are at least 25 years of age (Table 4, p. 2; Table 9, p. 3).
- The majority of recipients attend a CCC (77.3%) compared to 11.3% at CSU, 2.7% at UC, and 4.8% at forprofit privates (Table 1, p. 1).





## Competitive Cal Grant


Award requirements include financial and basic eligibility and a minimum 3.0 high school grade point average (GPA) or a minimum 2.4 college GPA. Cal Grant A awards provide for full systemwide fees at the California State University and the University of California, as well as tuition support at non-profit and for-profit private California colleges. Of these Cal Grant A awards, 316 were made for the March 2nd deadline, while 17.3 percent, or 66 awards, were made for the September 2nd deadline cycle.















# Competitive B


Award requirements include financial and basic eligibility and a minimum 2.0 GPA. Cal Grant B awards provide up to \$1,648 for books and living expenses for first-year students. Beginning with the recipient's second year of attendance, Cal Grant B awards also help pay for tuition and fees at public or independent four-year colleges or other qualifying institutions at the same level as the Cal Grant A award. Of these Cal Grant B awards, 9,925 were made for the March 2nd deadline, while 53.7 percent, or 11,508 awards, were made for the September 2nd deadline.













# **About the Applicants**

Applicants must meet multiple criteria to qualify. Submitting both the Free Application for Federal Student Aid (FAFSA) and the Cal Grant GPA Verification Form is the first step for students to be considered for a Competitive Cal Grant award. For 2014-15, over 305,000 students were successful in meeting the financial and basic eligibility criteria. Additional eligibility criteria may include a disadvantaged high school experience, an orphan or ward of the court status and the size of the applicant's family relative to household income. Of the qualified students, about 8 percent received awards. 279,384 qualified students remained unserved by this program.

The California Student Aid Commission is the state principal agency responsible for administering financial aid programs for students attending public and private universities, colleges, and vocational schools in California.
