### **Training for the General Public**

Cash for College Workshops for Students and Parents: The 2022-23 Free Application for Federal Student Aid (FAFSA) and California Dream Act Application (CADAA) are open now! Students must complete the application by March 2, 2022 to be eligible for Cal Grant. Given the decline in college enrollment as a result of COVID-19, it is crucial that students have access to financial aid resources. The Commission is hosting English and English/Spanish bilingual statewide Cash for College workshops to assist students and families with completing the FAFSA or CADAA, and Chafee Grant for Foster Youth applications.
