California Dream Act Service Incentive Grant Program (DSIG) 2021-22 Grant Application

The California Student Aid Commission (CSAC) will award up to \$3,000 per academic year (up to \$1,500 per semester or up to \$1,000 per quarter) to 2,500 eligible students. The grant will be available to the student for up to 8 semesters or up to 12 quarters while they have an active Cal Grant B award. Student shall perform at least 150 hours per semester or 100 hours per quarter of community or volunteer service with a qualifying service organization.



Qualifying Service Organization

- A nonprofit as defined in Section 501(c)(3) of the IRS code.
- Any federal, state, or local government entity.
- Any school on the Cal Grant Eligible Schools list on the CSAC website.
- Organization shall have been established for a minimum of two (2) years prior to the date that the student begins to perform service.
- Community or volunteer service performed is not advocacy of a political, social, or religious nature.
