SUBJECT: Non-SSN GPA Matching and Edit Screens

This Operations Memo from the California Student Aid Commission (Commission) provides information to schools regarding the ability to match and edit Non-SSN GPA data in WebGrants. The capability of matching and editing will be available through May 15, 2015.

- The Commission runs a nightly process that matches Non-SSN GPA data to the student's Free Application for Federal Student Aid (FAFSA) or California Dream Act application and will continue through the 2015-16 academic year.
- Applicants who fail the automatic matching process will appear on your school's Non-SSN GPA Unmatched report located on the 'Data Transfer' screen in WebGrants.
- Matching errors may be due to discrepancies between the submitted Non-SSN GPA data and the financial aid application. One of the most common matching errors is the student's address.
- School officials can match Non-SSN GPA data to the student's FASFA or Dream Act Application by using the Match Non-SSN Record to Financial Application screen in WebGrants.
- School officials can edit previously submitted unmatched Non-SSN GPA data by using the *Edit Non-SSN GPAs* screen in WebGrants.
- The Non-SSN GPA Matching and Edit Screens User Guide is available in the Help link in WebGrants.

Though the March deadline is approaching, the matching process will continue. It is imperative that students complete their 2015-16 FAFSA or California Dream Act application by Monday, March 2, 2015.

In some cases, the Non-SSN GPA may not match to the student's financial aid application until after the March deadline; however, the student will still be considered an on-time applicant. Once the Non-SSN GPA is matched, the student will be considered for the Cal Grant High School Entitlement award during the weekly awarding cycle.
