This Special Alert from the California Student Aid Commission (Commission) announces the opening of the registration site for the 2019 Statewide Financial Aid Workshops for high school counselors and student advocates.

The Commission works in partnership with the California Association of Student Financial Aid Administrators (CASFAA) and the California Community Colleges Student Financial Aid Administrators Association (CCCSFAAA) to host the annual Financial Aid Workshops series, which will consist of 43 half-day workshops this year taking place from August 22 to November 1, 2019. Optional, 2nd Sessions:

Of the 43 workshops this year, 18 will be offering free, 2nd sessions that will provide indepth training on the WebGrants System or a more detailed look at the CADAA. Attendees may register for the morning workshop, the 2nd session, or both. In most cases, lunch will be provided with registration of the secondary session. In some cases, attendees will have the opportunity to eat off-site and then return for the 2nd session. More information will be sent in your registration confirmation for those sites offering the 2nd session.
