Cash for College Workshops for Students and Parents: Although the March 2nd Cal Grant priority deadline has passed, it is not too late for students to submit a financial aid application. Other types of aid are still available! This is crucial information, given the decline in college enrollment as a result of COVID-19, so the Commission is hosting monthly English and English/Spanish bilingual statewide Cash for College workshops through August to assist students and families with completing the Free Application for Federal Student Aid (FAFSA) or California Dream Act (CADAA), and Chafee Grant for Foster Youth applications.
