The California Student Aid Commission (Commission) announces upcoming training webinars and virtual workshops.

Annual Statewide Financial Aid Workshops

The Annual Statewide Financial Aid Workshop series will begin again for the 2022-2023 season featuring both in-person events and virtual workshops. The Commission will begin offering in-person workshops in late August 2022 and our first virtual workshops in early September 2022. Once the schedule is finalized, the Commission will communicate that information and provide registration links.

These free workshops offer high school counselors, student advocates, student outreach coordinators and community partners the opportunity to attend a half-day training to obtain relevant financial aid information they can use to support their students. Upcoming trainings will take a comprehensive look at AB 469, new legislation which requires local education agencies (LEAs) to ensure high school seniors complete a financial aid application.
