SUBJECT: California Chafee Grant for Foster Youth - March Claim Schedules

This Special Alert from the California Student Aid Commission (Commission) notifies institutions that the 2023-24 Chafee Grant for Foster Youth (Chafee) initial budget allocation has been exhausted. As of March 11, 2023-24 Chafee payments are on hold pending additional funding for the Chafee program expected to become available in the coming weeks.

Institutions may continue processing Chafee awards and requesting eligible payments; however, both paper warrant and electronic file transfer (EFT) payments will be held and processed once the Commission has received additional funding. After these funds are exhausted, future claims can only be paid with unused Chafee funds returned to the Commission.

Update the Chafee Reconciliation Screen

As mentioned in <u>GSA 2023-03</u>, institutions must promptly return unused Chafee funds throughout the academic year. Please update the Chafee Reconciliation Screen documenting the date that issued funds were paid to the student. If a student was paid using institutional funds and Chafee funds were used as reimbursement, please use the payment "Issue Date" as the "Date School Paid Student."
