### **November Action Item:**

Federal Student Aid (FSA) released the 2024-25 FAFSA prototype on September 29, 2023. The FAFSA prototype was used in FSA's FAFSA demonstration webinar and at the NCAN conference in October. The FAFSA prototype is an amazing tool that is available to everyone to preview the new 2024-25 FAFSA and walk through the various predetermined use cases such starting a new application as a parent or student. The scenarios will allow users to experience the "who is my parent wizard," identify which contributors are needed and invite the contributors to the application. # In the Spotlight:

#### Better FAFSA: Who is a FAFSA Contributor?

A contributor, starting with the 2024-25 FAFSA, is anyone asked to provide personal and financial information, a signature, and consent to have their federal tax information transferred from the IRS to the FAFSA form. A student's or parent's answers on the FAFSA determine who is a contributor and use their information to establish eligibility for federal student aid.

- Contributors include the student and their spouse (if applicable), a biological or adoptive parent, or the spouse of the remarried parent listed on the FAFSA (the stepparent).
- Examples of those NOT considered contributors include non-adoptive grandparents, foster parents, aunts or uncles, and legal guardians. Dependency, marital status, and tax filing determine who is a contributor.
- All contributors will need to create an account on StudentAid.gov.

Once the contributor receives an email informing them that they have been identified as a contributor, they can expect an invitation to complete their part of the FAFSA. The contributor will then log in to their account using their FSA ID (account username and password), review the information required to complete their section on the FAFSA form, and then provide consent and approval and sign the form. If any contributors refuse to give consent on the FAFSA form, the student will be ineligible to receive federal financial aid. It is important to note that being identified as a contributor does not equate to being financially responsible for the student's education. See the links below for more information.

# Better CADAA: Embedding the AB 540 Affidavit in the CADAA (AB 1540)

Starting with the 2024-25 CA Dream Act Application (CADAA), students will experience a more streamlined financial aid process as they will be able to submit both their CADAA

and AB 540 affidavit form (also known as the nonresident tuition exemption form) at the same time. As outlined in the Commission's <u>Renewing the Dream</u> report, this change addresses the multi-step process that resulted in confusion, and in some cases even loss of financial aid for students.

The Commission will provide institutions with an "AB 540 Report" that will include students' responses to the AB 540 questions and can use it to determine students' eligibility. It is important to note that the Commission will *not* determine students' AB 540 status. Campuses are allowed to provide AB 540 affidavit forms to students who do not submit one via the CADAA.

# **Key Application Dates to Keep in Mind:**

- This year the Better FAFSA, Better CA Dream Act Application opening is delayed from the traditional October 1 date to **December 2023.** The exact date will be communicated once it has been determined.
- The March 2 priority deadline has been extended to **April 2, 2024 for Cal Grant**, due to the delayed application opening. Many campuses use the March 2 priority deadline to award institutional aid.
